EVENT DESCRIPTION AND GUIDELINES

- ~ All pistols will be inspected to insure they meet ISSF regulation. Please arrive at least 30 minutes prior to the start of your relay.
- ~ This is an Air Pistol competition, not a Free Pistol.
- ~ Men: 60 shot for record, with unlimited sighters before first record shot. Record shot will be three series of 20 shots each, 35 minutes per series.
- ~ Women: 40 shot for record, with unlimited sighters before first record shot. Record shot will be two series of 20 shots each, 35 minutes per series.
- ~ Other than the inspection, pistols shall be cased until they are brought to the line and shall be cased before leaving the line.

AWARDS	Men~Women~Junior Men~Junior Women: 1st, 2nd, 3rd place certificates. Great Prairie Coffee and Extra Virgin Olive Oil for 1st place champions.

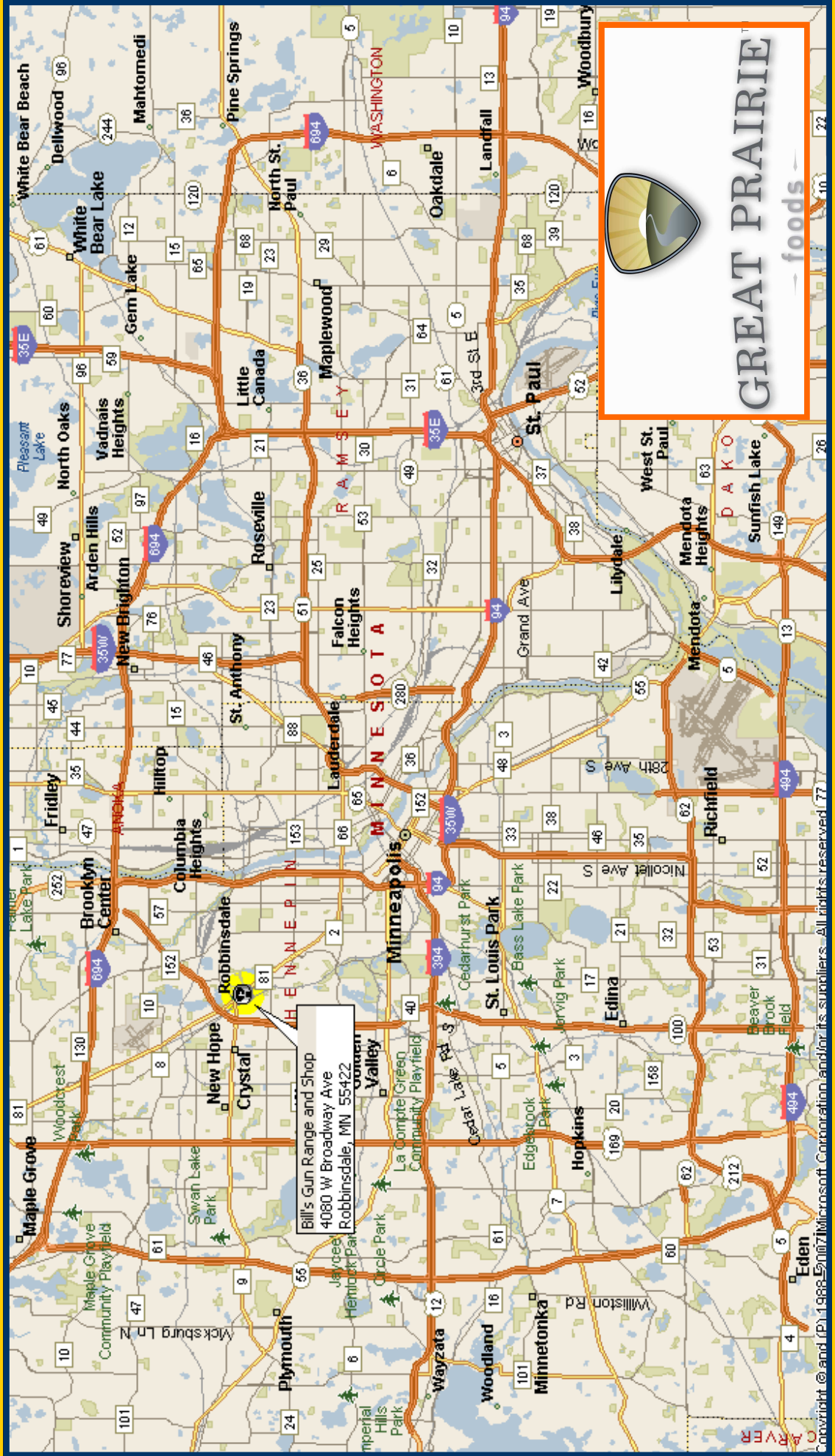

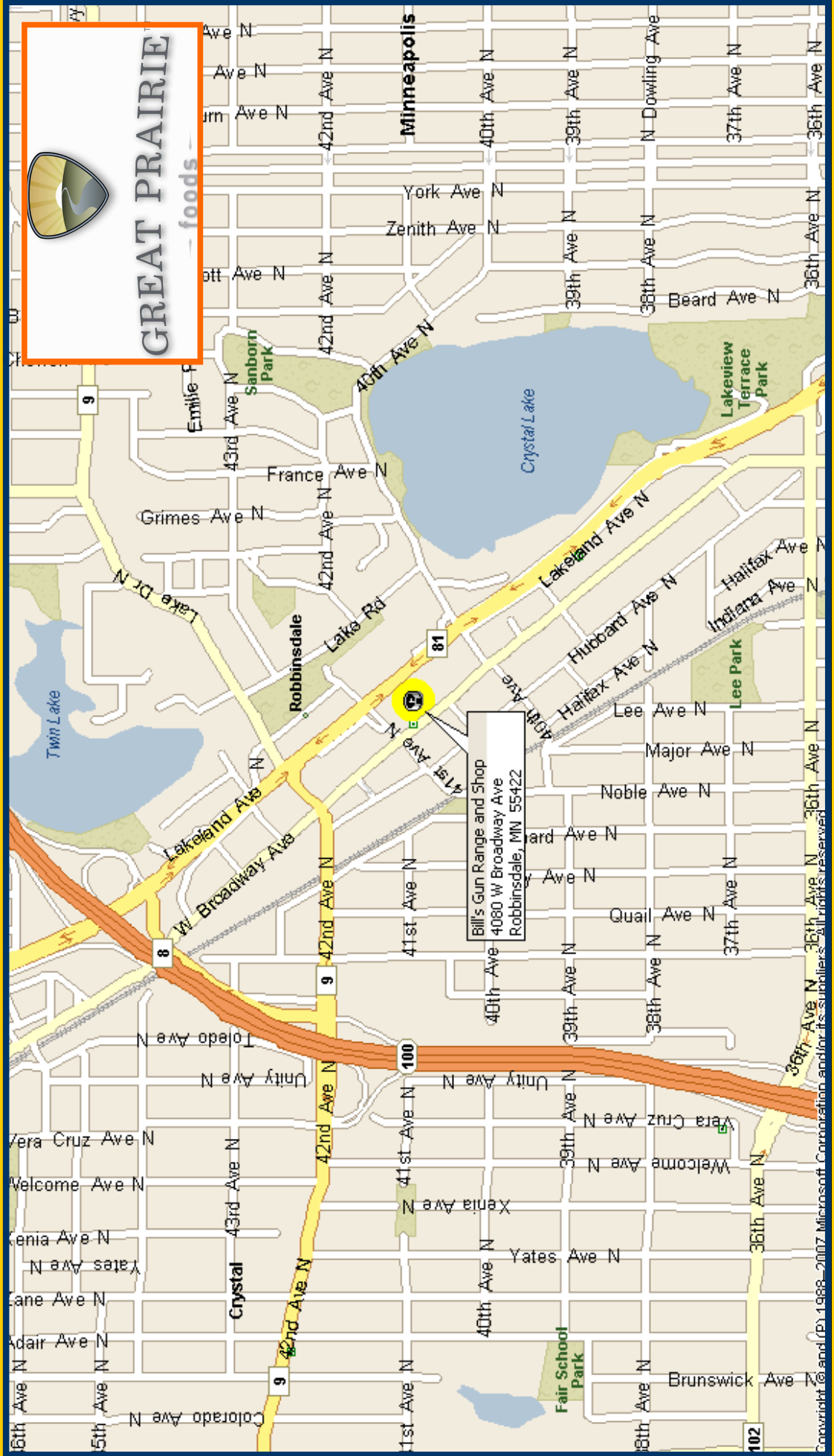

Note: This form must be read and signed before the participant is permitted to take part in event sessions. By signing this agreement, the participant affirms having read it.

In consideration of my involvement at the Great Prairie 10m Air Pistol Championships under the auspices of Great Prairie, Inc., I acknowledge, appreciate, and agree that:

4.
