WHO MAY COMPETE: Open to any member of the National Rifle Association who also meet the eligibility requirements specified under CMP rules. You must be a <u>resident of Illinois</u> and a member of the <u>Illinois State Rifle Association</u> to be the <u>State Outdoor Pistol Champion</u>. NRA and ISRA membership forms will be available at the range.

RANGE LOCATION: Approximately 10 miles west of Kankakee, Illinois on Warner Bridge Road, approximately 1 mile north of Illinois State Route 17.

REGISTRATION FEE: Registration fee is \$10.00, \$5.50 of it goes to the NRA and \$2.00 to the ISRA.

2700 MATCH ENTRY FEE: \$2.50 per match. Across the board for all 2700 matches, including registration fee is \$45.00. Advanced entry fee, received 7 days before match day, is \$40.00. Match entries cancelled 7 days before match date will receive full refund. **CMP SERVICE PISTOL "LEG" MATCH ENTRY FEE:** \$15.00 upon filling out special entry card. \$10.00 goes to the CMP.

NRA DISTINGUISHED REVOLVER MATCH ENTRY FEE: \$10.00 upon filling out special entry card.

Make checks payable to ISRA Conventional Pistol Committee.

ENTRIES: Entries will be limited to 100 competitors. 1 relay of 50 competitors per day. Competitors will fire the entire match in one day. Across the board entries will be given preference.

TIME: Registration begins at 8:00 a.m. Firing begins at 9:00 a.m. There will be a 20 minute break between the 22 caliber and centerfire matches. There will be an one (1) hour lunch break between the center fire and 45 caliber matches.

RULES: Current NRA and CMP rules will govern all firing. It is the competitor's responsibility to be familiar with such rules as well as those imposed by the Match Director. Competitor will score and change targets. Bring your stapler.

CHALLENGES: Challenge fee is \$2.00. A NRA referee or jury system will be used. The plug-type scoring gauge will be restricted to range personnel only

CLASSIFICATION: NRA classification system will be used for the championship. Unclassified competitors will fire in the master class. Any class with less than 5 entries will be combined with the next higher class. If there are less than 5 high masters or masters, they will compete for match winner only.

CATEGORIES: Competitors will not be separated into categories.

FACILITIES: 50 firing points, controlled by loudspeakers. Line is poured concrete and covered. Targets are electrically operated. Potable water and restrooms are available at the range. Lunch will not be served at the range. A restaurant is located about 1 ½ miles from the range.

STATE PISTOL TEAM POSTAL MATCH: This is not a fired match. The ten highest scoring Illinois residents in the 22 caliber national match course (match 2) will make up

the team. Each team member will be awarded a souvenir pin. First, second, third place teams nationally will receive individual awards from the NRA.

CMP SERVICE PISTOL "LEG" MATCH: This match will be fired each day after the 45 caliber rapid fire match.

NRA DISTINGUISHED REVOLVER MATCH: This match will be fired each day after the "Leg" match.

ARMS AND AMMUNITION:

CMP "Leg" Match: Competitors may use a pistol that was issued by the U.S. Armed Forces or a commercial pistol of the same type and caliber: U.S. pistol caliber 45, M1911, M1911A1 or U.S. pistol 9mm, M9, having not less than four (4) pounds trigger pull as prescribed in CMP competition rules. Competitors may use any safe 45 caliber 230-grain FMJ round-nose bullet or 9mm, 115 to 125 grain FMJ, round-nose bullet.

Distinguished Revolver Match: The revolver must be a factory manufactured revolver with NO external modifications, capable of chambering and firing a 158-grain lead round nose or semi-wad cutter 38 special cartridge. Trigger must have single and double-action capability and be capable of lifting 2 ½ pounds when the revolver is cocked for single action firing. Barrel cannot exceed 6 inches and adjustable front sights are prohibited. Stocks may be modified or changed but must be mirror images of each other. Only new, factory manufactured or commercially re-manufactured ammunition may be used.

Arms and ammunition will be weighed and inspected by the referee or chief range officer.

(CMP "Leg" Match and NRA Distinguished Revolver Match)

First Stage 10 shots Slow Fire @ 50 yards, B6 target Second Stage 10 shots Timed Fire @ 25 yards, B8 target Third Stage 10 shots Rapid Fire @ 25 yards, B8 target

AWARDS:

CMP "Leg" Match: Credit toward Distinguished Pistol Shot designation will be in accordance to CMP rules. Excellence-in-Competition Badges will be awarded by the CMP for those that qualify. A minimum of 10 non-distinguished competitors must shoot for any points to be awarded.

NRA Distinguished Revolver Match: Credit towards the Distinguished Revolver designation will be awarded in accordance to NRA rules.
