Eligibility:

This match is open to individual members of the NRA or shooters with NRA I.D. Number. Juniors may be members of a NRA affiliated Jr. Club. .

Location:

Minneapolis Rifle Club (located on Minnetonka Fish & Game Club Property) 8310 Hill and Dale Road, St. Francis MN 55330. See mrra.org for directions or call the contact below.

Time: Firing starts promptly at 9:00 AM, Squadding will be completed by 8:45 AM.

Course of Fire:

All Matches shot from the prone position, time allowed for target changes.

Match 1 Dewar Course A-23-5/A-25 targets, 20 shots each range, 5/10 shots per bull, 20/20 minutes, metallic sights.

Match 2 100 yards, A-25 target, 40 shots, 10 shots per bull, any sight.

Match 3 50 meters, A-26 target, 40 shots, 5 shots per bull, 20/20 minutes, any sight.

Match 4 50 yards, A-23/5 target, 40 shots, 5 shots per bull, 20/20 minutes, metallic sights.

Match 5 – aggregate of Matches 1, 2, 3 & 4.

Fees:

Registration: \$9.00 (\$4.50 – NRA fee, all shooters must pay, \$4.50 Club fee)

Entry Fee: Juniors free; Adult Entry Fee: \$10.00 (\$9.27 entry plus \$0.73 MN Sates Tax)

Package Fee:

Junior \$9.00; Adults \$19.00

NOTE - Juniors wishing to compete for open cash awards must pay the adult entry fee.

Governing Rules:

NRA Smallbore Rifle Rules, Revised January, 2010

NRA Rule 3.2 will govern rifles. NRA Rule 19.2 any competitor not having a NRA classification will fire in the master class. Rule 19.8.1 will govern your assigned class. If there are less than five entries in a class, they will be moved into the next higher class

Challenges:

\$3.00 challenge fee will be charged for each challenge and refunded if challenge is justified. See NRA Rules 16.1 for details.

Awards:
