SQUADDING: Squadding will begin at 08:00, June 17th. High masters will be squaded on the same relay to

the extent possible. Pre-registration, accompanied with fees, will be given priority.

RELAYS: Relays will be rotated each day. Competitors will remain on their assigned target for all three

days to the greatest extent possible.

CLASSIFICATION: The NRA classification system will be used in all individual matches. Please have your NRA

classification card or temporary score book with you. For class awards there must be at least five entries in that class. If there are less than five, those shooters will be combined with the next higher class. High Masters cannot be combined with any other class and can only compete for Match Winner awards if there are fewer than five shooters in the High Master class. Shooters without a classification card will shoot in the Master/Unclassified (MU) class

(rule 19.6)

COURSE OF FIRE Each Day - 80 Shot Regional Match Course (Rule 7.15) as follows:

Match 1: 200 yards, standing, slow fire, 2 sighters, 20 rounds for record, time -22 minutes Match 2: 200 yards, sitting, rapid fire, 2 sighters, 2 ten shots strings for record, time -60 seconds each string.

Match 3: 300 yards, prone, rapid fire, 2 sighters, 2 ten shot strings for record, time -70 seconds each string.

Match 4: 500 yards, prone, slow fire, 2 sighters, and 20 shots for record, time – 22 minutes.

Match 5: Aggregate of matches 1, 2, 3 and 4.

Day 2 – Matches 6 through 10, same course of fire as day 1.

Day 3 – Matches 11 through 15, same course of fire as day 1.

Match 16: Grand Aggregate of Matches 5, 10 and 15.

MATCH COURSE: Special notice – The sitting rapid fire stage (Match 2) will be fired immediately after the

standing stage (Match 1) is fired, so be prepared to do so.

DUTIES: Competitors will be required to score and pull targets. Failure to perform these duties will

result in disqualification.

CHALLENGES: There will be a \$2.00 fee for each challenge. A three person jury will be appointed prior to

commencement of fire.

AWARDS: Awards will be given in each class where there are 5 or more competitors in that class. The

10% rule will apply. Forty (40) percent of the Tournament Fee will be awarded to individual

competitors. Actual prizes awarded will be based on the total number of entries.

There will be High Grand Senior, High Senior, High Junior, High Service Rifle and High

Woman awards if more than 5 entries in any of these categories.

CAMPING: The range will be open for camping from 12:00 on Thursday, June 16th through 10:00 AM on

Monday, June 20th. Electric hook ups for campers are available. Clean outhouses are provided. The Club House will be made available for overnight use on Thursday, Friday, Saturday and Sunday. Contact James Fernandez 218 729 5975 ahead of arrival to ensure
