One (1) Relay per day. The relay will commence promptly at 9:00am each day. There will be a break between the .22 and CF matches and another after CF as a lunch break. The .45 match will commence after the 1 hour lunch break. Immediately following the .45 match, the CMP EIC & NRA Distinguished Revolver matches will be fired.

ELIGIBILITY: Open to any member or non-member of the National Rifle Association. However, you must be an NRA member to have your scores posted toward NRA awards.

LOCATION OF RANGE: Approximately 10 miles west of Kankakee, Illinois on Warner Bridge road, north of Illinois State Route 17 ... See map on final page

REGISTRATION FEE: Registration fee is \$10.00 - \$5.50 of this goes to the NRA and \$2.00 to the ISRA. Across the board fee is \$45.00 made payable by cash or by check (payable to Ron Wolflick). Email: rwolflick@mac.com ** Junior Competitors: Fee: (\$5.00).

MATCH ENTRY FEE: \$2.50 per match. Across the board fee for all matches, including registration fee is \$45.00. Advanced entry fee, received 7 days before match day, is \$40.00. Cancellations 7 days before match date will receive full refund. Make checks payable to: Ron Wolflick, 39W418 Herrington Blvd, Geneva, IL 60134.

ENTRIES: Entries will be limited to (96) competitors, 1 relay of (48) competitors per day. Competitors will fire the entire match in one day. Advanced entries received by the Saturday before the match will be confirmed by email/telephone. Post entries will be accepted to range capacity. Preference will be given to across the board entries.

RULES: Current NRA rules for outdoor pistol competition will govern this match. Verified alibi re-fires will be allowed. Competitors will score and change targets.

NRA Referee: Yes - On Site

Please bring your stapler.

CHALLENGES: A challenge fee of \$2.00 will be charged. The time limit will be one hour after scores are posted.

CLASSIFICATION: The NRA classification system will be used. Unclassified competitors will fire in the Master class. Competitors must present evidence of classification. Any class with less than 5 entries will be combined with the next higher class. Other

classes will not be combined with the master class. If there are less than 5 Masters or High Masters, they will compete for match winner only.

FACILITIES: (48) raised and covered firing points. Line is poured concrete, controlled by loudspeakers. Targets are electrically operated. Potable water and restrooms are available at the range. Lunch will (not) be served at the range. A restaurant is located about one (1) mile from the range.

Overnight camping, without hook-ups is permitted on the range. If you are not a range member, and plan to camp, please advise giving approximate arrival time, so we can make arrangements to have the gate open. Please arrive by 5:00pm if possible.

STATE PISTOL TEAM POSTAL MATCH: This is not a separately fired match. The ten (10) highest scoring Illinois residents within the .22 caliber National Match Course (Match 2) will make up the team. Each team member will be awarded a souvenir pin. First, second and third place teams nationally will receive individual awards from the NRA.

CMP SERVICE PISTOL MATCH: The CMP Service Pistol Match (Leg / EIC Match) for credit toward Distinguished designation will be fired each day after the .45 caliber Rapid Fire match. Entry fee is \$10.

NRA DISTINGUISHED REVOLVER MATCH: The NRA Distinguished Revolver match for credit toward the Distinguished Revolver badge will be fired each day after the service pistol match. Entry fee: None

MATCH 16. GRAND AGGREGATE – TOTAL OF MATCHES 5, 10 and 15

There will be a 15 minute break after firing the .22 caliber match and a one (1) hour 15 min lunch break after Center Fire.

INDIVIDUAL MATCH AWARDS: A cash award will be given to the overall match winner and to individual class winners. As the number of entries permits, 2nd and 3rd place awards may be presented.

Via I-57 from the South:

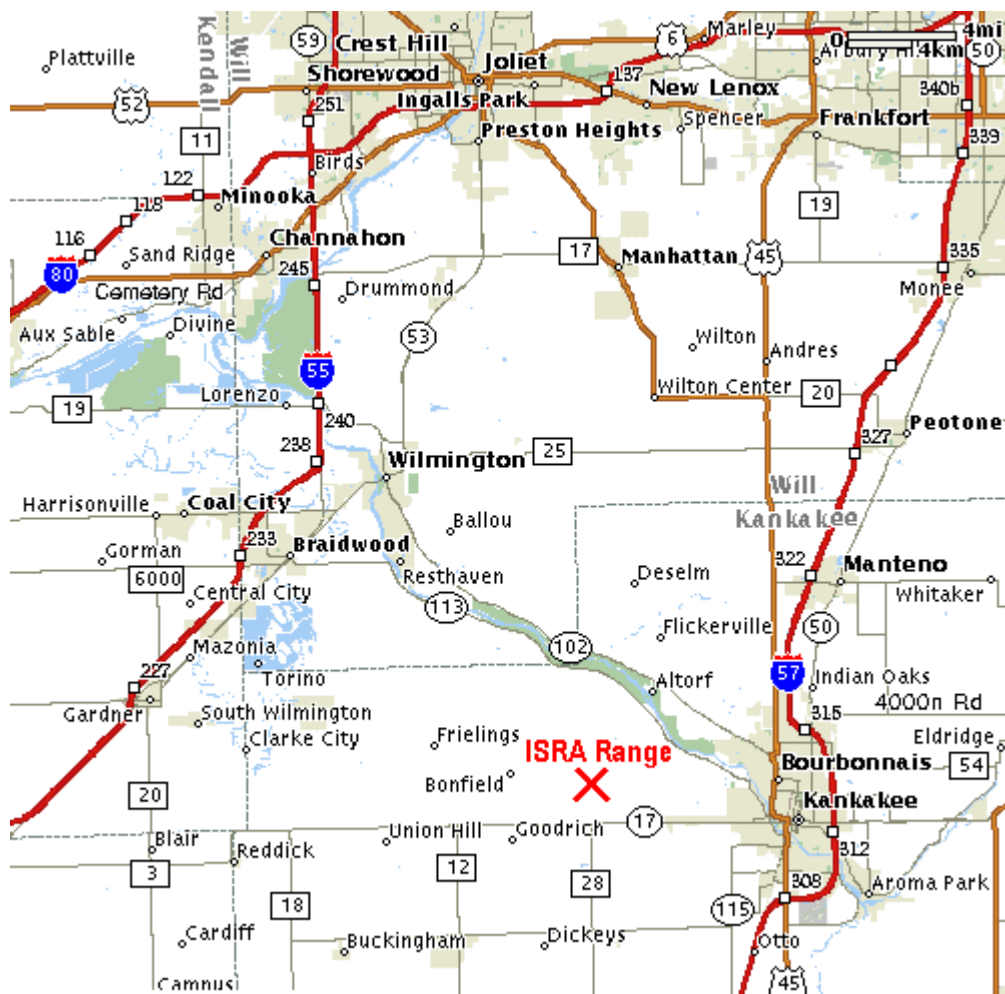
- Exit at Kankakee, Route 17 (exit 312).
- Turn left (west) for approximately 9 miles to Warner Bridge Road.
- Turn right (north) 1 1/2 miles to the ISRA Range.

Via I-55 from the North:

- Exit at Braidwood, Route 113 (exit 236).
- Follow Route 113 south through Braidwood and Custer Park approximately 13 miles to Warner Bridge Road.
- Turn right (south) 4 1/2 miles to the ISRA Range.

Via I-55 from the South:

- Exit Dwight Route 17 (exit 217).
- Turn right (east) approximately 26 miles to Warner Bridge Road.
- Turn left (north) 1 1/2 miles to the ISRA Range.
