DIRECTIONS TO RANGE: TWO BLOCKS EAST OF INTERSECTION OF U.S. HWY 10 & U.S. 71, TURN EAST ON COUNTRY ROAD #4 AND PROCEED EAST 1¼ MILE, TURN NORTH ON FIRST ROAD (WILL BE A SIGN POSTED THAT SAYS KNOB HILL) FOR ½ MILE, THEN EAST ½ MILE TO THE RANGE. (THE ROAD WILL CHANGE FROM TAR TO GRAVEL.) (FOOD & LODGING AVAILABLE IN WADENA)

MATCH CONDITIONS AND GENERAL INFORMATION: THE MATCHES 1-5 WILL BE FOR .22 CAL RIM FIRE PISTOL OR REVOLVER, AND MATCHES 6-10 WILL BE FOR ANY CENTERFIRE PISTOL OR REVOLVER .32 CAL OR LARGER, AND MATCHES 11-15 WILL BE FOR ANY .45 CAL PISTOL OR REVOLVER. THE KNOB HILL RANGE HAS 20 COVERED FIRING POINTS AND TURNING TARGETS AT 25 YARDS.
